



## Ann E. Zanon

June 9, 1912 - February 21, 2011

Ann E. "the Cake Lady" Zanon, 98, of Caspian and formerly of Crystal Falls, passed away on Monday, Feb. 21, 2011, at the Iron River Care Center in Iron River.

She was born on June 9, 1912, in Brogliano, Vincenza, Italy, daughter of the late Crescenti and Rose Ann (Rilievro) Rondon. She came to the United States as a child with her family in 1913. She settled in Crystal Falls, where she grew up and attended school.
