Lucille Jane Halls, 89, lifelong resident of Stambaugh passed away on June 16, 2011 at the Iron County Medical Care Facility. Lucille was born on March 3, 1922 to Eli and Bessie (Pearce) Johns in Stambaugh. She attended Stambaugh schools and graduated from Stambaugh High in 1939. She married Ward G.
