Warren Maki, 85, of Crystal Falls, MI, passed away on July 1, 2024, at UP Health Systems in Marquette.

Warren was born in Crystal Falls, MI, to Leo and Lillian Maki on December 6, 1938. He attended schools in Crystal Falls and graduated from Crystal Falls High School. He later graduated from Michigan Tech University with a Bachelor's Degree in Metallurgical Engineering.

He married Christine (Teena) Mello on September 5, 1959, in Eagle Harbor, MI. His employment history included being a Corvette plastics development Engineer, which eventually led to him starting his own Plastics Injection Molding company in Sault Ste. Marie in 1977. He eventually moved to Crystal Falls, MI, and opened up Northwoods Molders. Most recently he was the treasurer of St. Mark's Episcopal Church and the Amasa Senior Center. He loved reading, Sudoku puzzles and watching MSNBC.
